





Economists must collaborate courageously

To navigate pandemic trade-offs, policymakers need syntheses.

conomists, like researchers in many disciplines, are responding to the urgency of the COVID-19 pandemic. The immediate priorities are understanding the consequences of the crisis for public finances and international trade.

Scholars are scrambling to collect data on how many jobs are lost, what people can afford to buy and what shortages will emerge. Even constructing basic economic statistics such as inflation and gross domestic product is challenging when one-third, say, of activity in the economy has halted. Do we count a furloughed person as in work? What comprises a standard basket of goods when no one is going shopping? We need these measures to understand which groups of people will be intolerably affected so that governments can direct help to them. That's hard to do when standard metrics are having to be rebuilt on the fly.

There are many other pressing questions. When will the health toll of isolation, unemployment or delayed surgery outweigh that caused directly by COVID-19? What are the implications for next year's supplies of staple foods or of higher levels of long-term disability? How quickly can vaccine manufacture be scaled up? What release-from

factors, determine political and policy choices.

There is still a tendency to suggest a facile trade-off between lives and livelihoods. To be clear: whatever lockdown policies governments impose, or not, the pandemic will have a devastating economic impact. Every nation is groping for an approach that will save lives, mitigate the economic harm and prove feasible. This is not simple, and there is much we do not know across all fronts.

To share findings fast, the economics community has set up light-touch peer-review outlets, such as the European Economic Association's COVID-19 resource (see go.nature. com/2zgzeyz). The United Kingdom's Economic and Social Research Council (ESRC) is kick-starting an observatory to collate and translate research. Funders such as the ESRC and the European Commission's corona platform are rapidly processing research proposals. Academics who have long studied what previously seemed like niche topics, such as the links between financial uncertainty and stress or knots in supply chains, are producing research at extraordinary pace and providing public commentary to communicate their work.

But for any fruits of all this discovery to be a guide to policy, they must be used. I am concerned that government ministers and officials are having to judge for themselves — at a time when they are massively overstretched and under pressure — how to combine insights from various

- New accreditation standards for 879 business schools in 50+ countries and territories.
- RRBM summit last year had a substantial impact on my thinking as I wrote the standards.

Service to Society

- "Societal Impact" is the unifying theme and one of the 10 Guiding Principles of the 2020 Business Accreditation Standards
- Key Expectation: AACSB-accredited business schools can and will collectively make a positive impact on society and promote our vision of business and business schools as a force for good in society.



Societal Impact

- Is woven throughout the standards:
- Standard 1: Strategic Planning
- Standard 4: Curriculum
- Standard 8: Impact of Scholarship
- Standard 9: Engagement and Societal Impact



Valuing Both Basic and Applied Contributions Standard 8: Impact of Scholarship

- Peer-review articles are still expected of all schools
- The types of PRJs and other intellectual contributions should be aligned with the school's mission
- High-quality applied and pedagogical research is appropriate where tied to the school's mission.
- Likewise, high-quality basic research is appropriate where tied to the school's mission as a research-intensive institution



Move away from counting....towards recognition of impact

- We emphasize it is not the count of publication that is paramount; it is the outcomes and impact of the scholarship produced.
- The standard requires schools to collaborate with a wide variety of external stakeholders to inform theory, policy, and/or practice of business.



Standard 9: Engagement and Societal Impact

Key Point: The school is expected to make a positive impact on society through other activities outside research as well.

Transforming Research to Serve Society among Leading Chinese Business Schools



- Ten deans of C9+ Business Schools issued the Action Plan of Management Research for Service to Society:
 - Action 1: We will improve the post-graduate curriculum to encourage students to conduct more societally beneficial management research.
 - Action 2: We will improve the faculty evaluation system to encourage faculty members to conduct management research that will identify business practices for a better society.
 - Action 3: We will increase the weight on societally oriented management research in the faculty recruitment and promotional policies.
 - Action 4: We will initiate new policies to strengthen the collaborative research relationships between researchers and their research stakeholders.
 - Action 5: We will initiate new policies to emphasize the values of societal service in the evaluation of research grant, journal articles, and research projects.
 - Action 6: We will jointly explore and optimize the education programs that are best suited to promote management research for a better society.

Transforming Research to Serve Society at Tsinghua SEM: Research Initiatives



- Launched the **Tsinghua SEM IMPACT Research Fund** to provide faculty with funding and resources to encourage them to carry out research with academic and social influences in the end of 2019.
- Initiated the **Tsinghua SEM Thought Leadership Book Series** to encourage faculty to write high quality books as well as maximize Tsinghua SEM's academic and social influence in the end of 2019.

Transforming Research to Serve Society at Tsinghua SEM: P&T Policy Revision



- Starting from the spring of 2020, the newly revised academic requirement for faculty promotion is adopted: one of the best scholars in his/her academic field in Asia Pacific. If applicable, consider the relevance of China issues when making the comparison with peer scholars.
 - The minimum publication quantity requirement mainly focus on top-tier journal articles
 - Emphasize service to society as well as relevance to Chinese issues in the evaluation

Transforming Research to Serve Society at Tsinghua SEM: P&T Policy Revision



- Extra criteria for full professors:
 - Social recognition (e.g., policy, social and management practice impacts)
 - Outstanding teaching achievements

Transforming Research to Serve Society at Tsinghua SEM: Faculty Salary Evaluation



- Assigned a task force for faculty salary evaluation reform to increase the weight of **service-to-society** in the evaluation system in the fall of 2020.
- The new evaluation system will become effective from the fall 2020.

WHY is BUSINESS ACADEMIA missing IMPACT?



- Research **questions** are not jointly developed with our Stakeholders
- Our Stakeholders are only **involved** (if at all) at data collection stage
- No <u>voice</u> given to Stakeholders......and no <u>voice</u> given by Stakeholders to us
- Virtually no global scale, cross-disciplinary, multi-stakeholder, programs.
- Small, disconnected, research centres
- Academic **Associations disconnected** from Business, Policy, Civil Society
- Lack of structural knowledge <u>translation</u> for Stakeholders
- No measure of **impact** of research projects




A (Multi-Stakeholder) High Impact Business Research Institute (HIBRI)



- PARTNERS: Academia (RRBM, Schools/Uni, centres, acad. associations) and key Stakeholders (business, accreditation, policy-makers, funders, civil society)
- PURPOSE: collect and direct major resources to large scale, multi-disciplinary,
 high impact business research programmes:
 - CONTENT: transition to inclusive, sustainable, stakeholder capitalism/enterprise models
 - PROCESS: knowledge co-creation, field experimentation, results translation, collective diffusion, impact assessment/sharing/comparing, embed lessons in following waves of funding
- Some MODELS: Marketing Science Institute, CERN (particle physics), Genome program...
